GENERAL CONDITION

The court is now into its 20th season after total re-construction in 1998. In 2012 a root barrier was inserted along the south-eastern corner, tree root damage was repaired and the surface painted and re-lined. Moss is a constant problem and the court was professionally cleaned in April 2016 and moss killer has been applied by users since that time. The court is structurally in reasonable condition with some surface erosion in places but has little impact on play. It should last another 3 seasons before major re-surfacing becomes necessary, which is likely to cost at least £16,000. The sign and bench seat were replaced last season and we thank Annie Cawthorn for the donation of the replacement seat.
